Momentarily push the Flash Pattern button: Once for next pattern Quickly 3 times for reset to FP#1






Vacuum Magnet Mount (Standard)

Wiring Code

RED: To +VDC (fuse @ 10A)

BLACK: To Chassis Ground (-)

WHITE: For Simultaneous or Alternating Flash

-Group 1 Units: (Wiring - WHITE connected to RED) will flash together

- Group 2 Units: (Wiring - WHITE not connected to RED) will flash together

*Group 1 Units will alternate with Group 2 Units

YELLOW: Flash Patterns & Synchronization

-Connect YELLOW wires of all head together for synchronization *All heads must be set to the same pattern

A WARNING
